- Avalanche danger – YOU COULD BE SEVERLY INJURED OR DIE IN AN AVALANCHE IN JAPAN. YOU WILL BE RIDING IN POTENTIAL AVALANCHE TERRAIN IN JAPAN. PEOPLE HAVE DIED OR BEEN SERIOUSLY INJURED IN CHILE BEFORE BECAUSE OF AVALANCHES.
- Collisions with other skiers and snowboarders.
- Falling into tree wells or streams.
- Attacks from wild animals (but not limited to: bears, stray dogs).
- Traffic accidents in the course of travelling on mountain or city roads (as a vehicle driver or passenger).
- Collisions with visible and hidden obstacles (but not limited to: fences, pylons, power lines, trees, tree wells, cliffs).
